I hereby acknowledge adopting a dog/puppy from AnimalSave and agree that I will:

- 1. Provide this animal with proper humane care, food, water, shelter, exercise and all other necessities for a healthy, happy life.
- 2. Provide him/her with veterinary treatment at my expense, including all necessary vaccinations, heartworm prevention and other veterinary care.
- 3. Work with a trainer to properly socialize and train this dog/puppy and work with a behaviorist if needed.
- 4. Keep this animal as a family pet and companion.
- 5. See that this dog/puppy wears an identification tag with my name and current phone number at all times.
- 6. Comply with all state and local laws and ordinances relating to the keeping of this dog/puppy, including license and leash laws.
- 7. Not debark this dog/puppy.
- 8. Provide an indoor/outdoor home environment. I will not permit any dog to be housed in a garage or outdoor only situation.
- 9. Provide for adequate fencing to ensure the dog/puppy has a safe area for outside exercise.
- 10. Not tie or chain this dog/puppy outside or allow it to ride in the back of an open vehicle.
- 11. Notify AnimalSave immediately if I find, for any reason, that I am unable to keep this animal. I agree to continue to care for the animal in my home until AnimalSave can move the animal into a foster home or permanent home. I will never have the animal euthanized for any reason other than an end-stage injury or illness where the animal is suffering, nor will I surrender him/her to Animal Control or to any third party without the express approval of AnimalSave or release him/her to fend for him/herself. Abuse, neglect or failure to comply with any of the provisions of this agreement will result in the removal of the dog/puppy from my custody.
